The offer should be prepared in English on the form constituting Appendix 1 to this Request for quotation and should contain, in particular, the signature of persons authorized to represent the bidder, date and place of preparation.

The Carrier is obliged to attach the following documents to the Offer:

- a) Scan of the Transport License.
- b) Scan of the current OCP policy.

c) In the case of bidders who are entrepreneurs - a current excerpt from the relevant register or another official document, which shows the legal status of the bidder, the method of representation, as well as the names and surnames of persons authorized to represent him, in the case of signing the bid by a proxy - a document confirming the authorization of the proxy to submit the offer, in the form required by law.

d) Written declaration of the bidder that he has read the Request for quotation and its terms and conditions, and that he accepts them without reservations.

6. Deadline for submitting offers

7. Offer selection criteria

- 1. Offered rates **ALL IN** in € currency
- 2. Age of the fleet and adaptation to the requirements of DB Schenker
- 3. Experience in servicing the Polish Spanish market

8. Conditions of conduct

- 1. The carriers meeting the requirements specified in the Request for quotation may participate in the procedure.
- 2. DB SCHENKER reserves the right to request the Carrier to submit to DB Schenker the original documents sent by scan in the course of the procedure, including in particular the offer and its attachments at the time and place indicated by DB SCHENKER.
- 3. The carrier remains bound by the offer for at least 30 days from the date of its submission.



- 4. DB SCHENKER reserves the right to send additional questions to the submitted offers and explanations to the submitted offers.
- 5. DB SCHENKER reserves the right to respond only to the selected offer and to withdraw from the selection of the offer and conclusion of the contract at any time without giving a reason.
- 6. DB SCHENKER reserves the right to indicate the date and place of conclusion of the contract and its content.
- 7. If an offer is selected, DB SCHENKER is obliged to inform in writing or electronically the Carrier whose offer has been selected of the intention to conclude a contract with it. The notification specifies the date by which the contract should be signed and the place of its conclusion. The moment of concluding the contract is the moment of signing the contract by both parties. If the Carrier fails to sign the contract within the prescribed period, DB SCHENKER may terminate the procedure without choosing or conclude the contract with another Carrier who participated in the procedure.
- 8. DB SCHENKER reserves the right to withdraw from the procedure or to cancel it without giving any reason and at any time, without incurring any legal or financial consequences.
- 9. The Request for quotation or the terms of the procedure may be changed or revoked by DB SCHENKER at any time without giving any reason.
